### **Candidate Profile:**

Melissa Doane has served the Town of Bradley in several capacities for more than 19 years, including as manager, deputy town clerk, treasurer, tax collector, road commissioner, and general assistance administrator. She served on the LPC for this past term, finishing out the term as chair. Melissa also serves on MMA's Executive Committee, currently serving as vice president, and has also served on the MMA Strategic and Finance Committee and currently serves on the board of Maine Town, City and County Managers' Association. Melissa would like to continue to serve on the LPC because she feels that if she is elected to serve another term, her experience will help her to provide a voice for smaller rural communities in Maine.

Benjamin Breadmore has served as town manager and code enforcement officer for the town of Holden for almost 10 years. Prior to that he served as code enforcement officer for the City of Brewer for four years. Benjamin has served this past term on the LPC, stepping up as alternate to fill a vacancy, and also served as an alternate in prior terms. He would like to continue his service because he feels that input from small to medium sized communities is very important.

Andrew Hart has served as town manager in Carmel for the past three months. Previously, he served as town manager in Chelsea from 1992-1994 and in Union from 1994-2008. Andrew also served as Knox County administrator from 2008-2024. He served on MMA's Executive Committee and Strategic and Finance Committee and served on the LPC from 1994-2008. Andrew would like to serve again so that he can be involved and up to speed on legislative items, including PFAS issues. He has missed serving on the LPC and feels that serving again would bring value to Carmel and the towns in his district, particularly given his extensive experience on the committee.

Paula Scott has served as town manager and treasurer in the Town of Hampden for nearly five years. She came to Hampden in 2016 as town clerk and was promoted to assistant town manager in 2018, interim manager in 2019 and town manager in 2020. Before coming to Hampden, she served as town clerk, deputy treasurer and deputy tax collector in the Town of Newport for 17 years. Paula serves on the newsletter committee for the Maine Town & City Clerks' Association and served this past year on the LPC, having stepped up as alternate when Melissa Doane became the chair of the committee. Paula is interested in continuing her service because of her interest in land use policy and is also very concerned about municipal solid waste management and landfill use. She is also a big proponent of home rule authority.
