Candidate Profile:

Gary Lamb has served as City Manager in Hallowell for the past three years. He also served as Town Administrator in Waterboro for 8 years from 2013-2021 and prior to that served as Town Manager in Greenville from 2010-2013. Gary served as Director of Community Development and Planning for the Town of Old Orchard Beach from 2007-2010, Assistant Town Planner in Kennebunk from 2005-2007, Deputy Code Enforcement Officer in Kennebunkport from 2003-2005, twenty years as Town Meeting Member in Sanford, as well as serving on Sanford's planning board and council. Gary has served on MMA's Wind Advisory Committee and is currently MMA's representative to the Governor's Climate Council. He has served the past four terms on the LPC and would like to continue to serve because he wants to help create the most efficient government services possible, directed by well thought out public policies. Gary is fiscally conservative, would like to help create an environment to stimulate municipal government to get smaller and enjoys helping create policy, ordinances and statutes to maximize government efficiency yet still meet voter mandates. Gary would also like to stop the Legislature from being able to submit "concept draft bills" which merely give a title but no further detail until just before the public hearing. He is a former Inland Fisheries and Wildlife Biologist who believes in good science first, and political winds second, whenever possible.

Anthony Wilson has served as town manager in the Town of Winthrop for the past year. He previously served as manager in the Town of Belgrade for three years, spent 12 years working for the City of San Angelo, TX, including seven years as communications director. Prior to that, he worked for 20 years as a journalist covering local government. Anthony holds a master's degree in public administration, is vice president of the Kennebec Valley Council of Governments and served as chair of the Belgrade Comprehensive Plan Committee. He serves on the Maine Town, City and County Managers' Association's Communications Committee and is a regular contributor to the Association's newsletter. He would like the opportunity to serve on the LPC because he is interested in how legislative issues impact municipal government. He has a great respect and appreciation for MMA's advocacy staff and wants to assist in its efforts. Anthony has testified before the Legislature and finds it gratifying to relate Winthrop's experience to lawmakers. He is particularly interested in issues that impact small communities, such as the one he serves.
