Additional Information

- Agreed Value option is only available for Fire and Rescue vehicles.
- Agreed value means that in the event of a covered loss, the member will receive the lesser of:
 - 1) The cost to repair the vehicle; or
 - 2) The cost to repair or replace a damaged part with a part of like kind and quality without a deduction for depreciation; or
 - 3) The cost to replace the vehicle with a comparable new vehicle manufactured to current specifications set by the National Fire Protection Association ("NFPA"), the U.S. Department of Transportation, or other similar associations, departments, agencies, or organizations; or
 - 4) The Agreed Value, which is the Cost New dollar figure, for the vehicle as shown on the Automobile Schedule.
- The **Agreed value** will be determined by the MSRP or Purchase Price. Proper documentation showing the MSRP, or Purchase Price must be submitted (bill of sale, title, original sales invoice and/or written documentation from the manufacturer) to obtain the requested **Agreed value**.
- Fire and/or Rescue vehicles older than 50 years or that have a salvage title are not eligible for **Agreed value** coverage.
- Items that are stored in/on the vehicle but are not permanently attached should be listed on the mobile equipment schedule (PPE, ladders, tools, spike mats, etc.) Other permanently attached equipment such as plows, sanders, etc. should be included in the vehicle value.
- Police vehicles include the cost of the police package (i.e., emblem, light bars, cages) in the vehicle value.
- If there is a lease or loan for the vehicle, provide a complete copy of the Lease/Loan agreement with the financial institution. We will review and provide appropriate certificate of insurance if required.
