#### **Location of Exhibits**

The 2025 MBOIA Code Conference will be held at Sugarloaf Mountain Resort Hotel in Carrabassett Valley, Maine. MBOIA reserves the right to make such modifications and changes in exhibit space assignments and floor plan as may be necessary to meet the needs of the exhibitors and registrants. Space is limited, and exhibit space will be assigned by date received on a "first come - first *paid*" basis. **CHECKS ONLY.** 

#### **Exhibit Space Equipment and Service Information**

Each exhibit space rented will include an 8-foot skirted table (see exhibit floor plan for placement). Power will be provided.

#### **Exhibitors' Representative Admission**

Each exhibit space rented will include an 8'x 6' space, 8' table with cover and two chairs, standard 110 power, Continental Breakfast, lunch and breaks for both days. Includes one reception drink ticket per exhibitor.

#### Installation and Removal Time

Exhibitors will be allowed to set up between the hours of 9:00 AM to 11:00 AM on Monday, May 19, 2025. **Displays must be installed by 11:00 AM on Monday, May 19th.** There is space available for storage of empty cartons, crates, etc, under your exhibit table only.

#### Security and Insurance



#### Individual Call-In deposit and cancellation policies for groups:

We understand that your attendees will be making their own reservations directly with our Reservations Department. To do so, they may call our reservations department at (866) 865-1019. Be sure to advise your attendees to refer to the **Maine Building Officials and Inspectors Association - 2025** group when making their reservations so that they will qualify for the special group rate.

A deposit of 50% will be required at the time the reservation is made. Final payment for individual call-in reservations is due 14 days prior to arrival and will be automatically charged to the credit card on file. To use a different form of payment please call reservations more than 14 days prior to arrival to change payment type.

Upon arrival, a security deposit, in the form of a credit card authorization of \$200, will be taken. The credit card is not charged unless damages are found or there is evidence of smoking in a non-smoking room. No refund for late arrivals, early departures, no-shows, or downgrades

Credit cards accepted are MasterCard, Visa, Discover or American Express.

Reservations cancelled before the cut-off date will be subject to a \$50.00 per room administrative fee. Reservations cancelled within 14 days of arrival will be refunded only if the room can be resold, and are subject to a cancellation fee of 50% of the room total or an equivalent to the first nights lodging. No refund for late arrivals, early departures, no-shows, or downgrades.
